

(15) Description of Equipment:

The fire damper series FKR-EU is used in ventilation ducts to prevent the spread of fire and smoke in ventilation systems.

The fire damper is designed with a release mechanism with fusible link and spring mechanism with optional approved limit switches type 07-2511, spring return actuators ExMax-15-BF-TR or RedMax-15-BF-TR with the thermoelectric release ExPro-TT.

If the temperature in the ventilation duct exceeds 72 °C or 95 °C in the event of a fire, the fusible link or thermoelectric actuator ExPro-TT trigger and the fire damper is closed by the spring mechanism or spring return actuator.

The electrical connection is made via the ExBox-BF-TR.
